**Treasurer's Report** Jan Bitter - Financial Report attached.

Treasury balance much improved with recent (much appreciated) donations from square dancers through Thrivent & Alliant Energy connections and from Packer

concession work. Important to keep 501(c)(3) designation.

- 1. Jan gave further explanation about income from Thrivent dollars, and from Alliant Energy, which are designated or matching funds from certain organizations. .
- 2. Wolf River members will again work at Packer concessions and likely donate a portion of proceeds.
- 3. Jan will inquire as to why we are being charged a \$5.00 monthly bank fee.
- 4. No income yet from smile.amazon.com rebate program . May need to accumulate a certain amount before receiving a distribution.

5. Discussion about alternate investment opportunities for the \$10,000 in the CD, which matures in September. This is intended to be used as seed money for a future bid for a national or regional convention. Currently earning very little interest. Still need some liquidity. Ted Palmen commented that Wisconsin will likely not in future bid on a national convention. What, then, should be the intend purpose this fund? Brenda Deal suggested that there may be an option in future for Wisconsin to join in a regional bid for a convention, so we should not change the purpose of the fund this time.

Regardless of the purpose for the fund, the consensus of the group was that, rather than continued investment in CDs, a better return can be obtained with an alternate type of account.

#### 1. Promotional Pens - Charlie Bitter

#### 2. Dancer Hall of Fame - Scott Deal

Scott & Brenda Deal are chairpersons for the Dancer HOF Committee

Nomination forms were distributed - four nominations received.

Forms also available on the sda-wi.org web site.

Badges have been developed. First presentations at the 2016 convention.

Nominate any time; forms go initially to President of SDAW.

Will share display table with Caller HOF.

#### 3. Discussion of moving SDAW meeting to Saturdays.

Reports from discussions in area meetings --

Central Area (Barb Oelke): Attendees travel long distances and get back to home area late on Sunday. Saturday meetings would be preferred.

Wolf River Area (Ellery Gulbrand): Hall availability can be an issue on Saturdays, and many people work on Saturdays. Sunday meeting day preferred.

Regarding dances on each day, Brenda Deal informed the group that one club dances on first Sunday; three clubs dance on first Saturday.

Southeast Area (Wayne Mattson): Meeting on Sunday allows for host area to prepare on Saturday.

#### 4. Publications Brenda Deal

<u>Where to Dance</u> tri-fold has been updated. 1000 printed; to be distributed between areas and some for National Convention.

Total cost = \$135.00. Deals have donated \$50.00. Will submit an invoice for \$85.00.

## 5. Competition in Square Dancing: Rose Marie Kerner

Charlie Bitter & Rose Marie Kerner: Keep in mind that current by-laws of WSDLCC and SDAW state that there will be no promotion of competition in square dance in Wisconsin.

Topic was an agenda item at last meeting, to be discussed at area meetings. Reports from area meetings on this topic.....

Southeast Area (Wayne Mattson): Would be in favor of amending by-laws as necessary. This type of activity is popular in other area of the US and in Canada. However, these events should be seen as **voluntary and fun** and organized primarily and initially for Youth. Many judging formats are used.

Central Area (Barb Oelke):

- 1. There were some individuals strongly opposed to any form of competition. In this case, there may be some misconception about how serious these activities would be.
- 2. Perhaps by-laws would not need to be amended if the concept would be presented initially as square dance 'games', for example.
- 3. Those who go to National Convention or other state conventions where competitions are held could recommend some type of similar activities that would work in the Wisconsin environment.
- 4. Only after some experimentation would we need to consider amending by-laws.

Ellery Gulbrand proposed that an educational session be presented at state convention on this topic to get input and ideas from a greater cross section of dancers.

Brenda Deal: USDA has guidelines for competition.

Others had examples of fun and competitive activities that they have seen elsewhere to reinforce the idea that these types of activities are done in many other venues.

Dave Schulz will look into addressing this topic in some way at the 2016 convention.

1 .Quilt Rack Bob Dahnert

Request for funds to make a free standing quilt rack for the new quilt that was made: estimated \$80.00. Quilt cannot be displayed without a new rack.

#### 2. Transition to shorter call list dance program state wide Eric Tangman

Eric re-introduced the topic for discussion of transitioning the standard dance program in all clubs in Wisconsin and state convention from Mainstream to a condensed call list program such the 'Club 50' program. This would reduce the time it takes for a new dancer to participate in regular dances, which has been an area of concern for some time. Callers would need some education about how to transition, but current dancers likely would not notice the difference with the removal of calls that are infrequently used. Some callers are now using a condensed call list without dancers even realizing it. Calls removed from the current Mainstream list would be incorporated into teaching of the Plus program.

Leadership in such a change can come only a governing body such as the SDAW. Individual clubs cannot make such a change on their own, as their dancers would have no other places to dance, nor would they be able to dance at the convention. Once areas and members of the SDAW agree, a recommendation would then be made to the State Convention Board, which is a separate entity.

Charlie Bitter noted that Callerlab has a condensed teaching list also, which is slightly different from the Club 50 list. In addition, there is a Callerlab Basic program list, which is also slightly different form the other two. He suggests that, If we are to abide by by-laws referencing Callerlab programming, then we probably should recommend using the Callerlab approved list. Eric has proposed a change to a shorter call list, but not to a specific list.

Per decision of the of the president, further discussion tabled for a future meeting. A comparison of call lists would be helpful for future discussion.
